Operating Instructions

- Transmit no more than 50 % of the time. To transmit (talk), press the Push-To-Talk (**PTT**) button. To receive calls, release the **PTT** button.
- Hold the radio in a vertical position in front of the face with the microphone (and other parts of the radio including the antenna) at least 1 in. (2.5 cm) away from the nose or lips. Antenna should be kept away from the eye.

Figure 1: Radio Control Functions

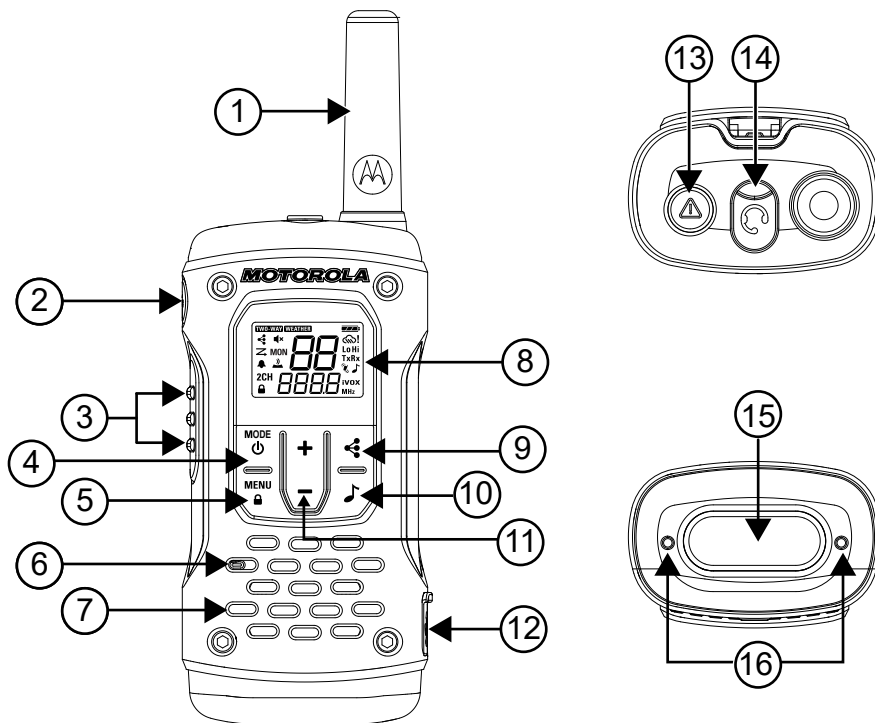





Table 1: Radio Controls

Item Number	Buttons and Functionality
1	Antenna.
2	<p>Flashlight button. Turn on or off the flashlight and to change light color between red and white by pressing the Flashlight button.</p> <p> NOTE: Red light helps preserve vision in the dark. The flashlight turns off automatically after 30 minutes of non-activity or if the battery level is below 50%.</p>
3	<p>PTT High/Low button.</p> <ul style="list-style-type: none"> • Talk by pressing and holding the PTT High/PTT Low button. You can release the PTT button to stop transmission.

Item Number	Buttons and Functionality
	<ul style="list-style-type: none">Exit menu screen and return to home screen by pressing the PTT High/PTT Low button. <p> NOTE: PTT Low button always transmit at 0.5 W. PTT High button transmits at a higher power when you select a high power channel (channel 1–7 and channel 15–22).</p>
4	<p>Mode Switch/Power button.</p> <ul style="list-style-type: none">Toggle between Two-Way and Weather modes by pressing the Mode Switch/Power button.Turn on or off the radio by pressing and holding the Mode Switch/Power button.
5	<p>Menu/Lock button.</p> <ul style="list-style-type: none">Enter and scroll through the menu by pressing the Menu/Lock button.Lock or unlock the Menu/Lock button by pressing and holding the Menu/Lock button.
6	Microphone.
7	Speaker.
8	Screen.
9	<p>Easy Pairing button.</p> <ul style="list-style-type: none">Copy the channel and sub code settings from Radio A to Radio B.<ul style="list-style-type: none">Prepare Radio B for pairing by pressing and holding the Easy Pairing button until you hear a beep.Broadcast the channel and sub code settings by pressing and holding the Easy Pairing button on Radio A until you hear a double beep. <p> NOTE: You can copy from one radio to multiple radios simultaneously.</p>
10	<p>Call Tone button. Send call tone (ring tone) to other radios by pressing the Call Tone button.</p>

Figure 2: LED Icons and Indicators

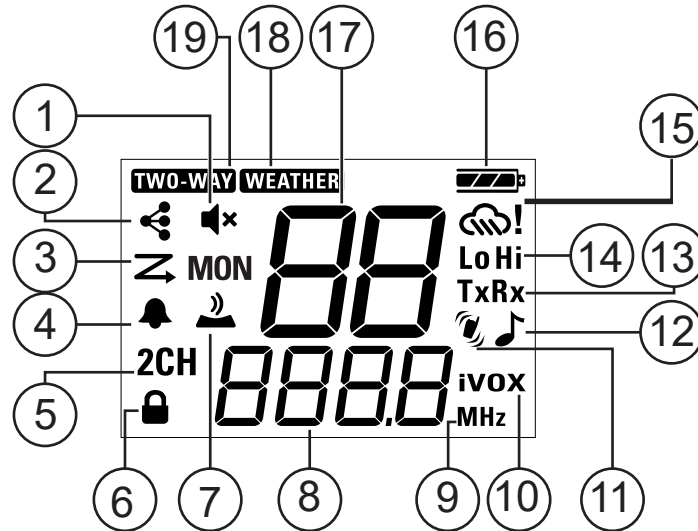

Chapter 2

Getting Started

This chapter provides instructions on how to prepare your radio for use.

2.1

Installing and Charging Batteries

Procedure:

- 1 Turn off the radio.
- 2 Before installing the batteries, observe for polarity.
- 3 Charge the battery by using the standard USB power source.

Charging is complete when the battery icon on the radio stops blinking. Charging takes up to 8 hours.



NOTE:

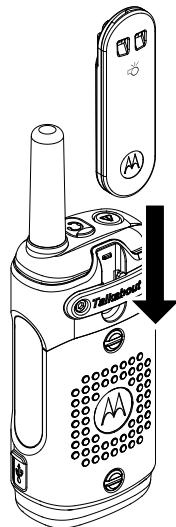
- You can use Alkaline AA batteries.
- Motorola Solutions recommends that you use only the battery that comes with your radio. Otherwise, your radio might sink.

2.2

Attaching the Belt Clips

Procedure:

- 1 Attach the belt clip to the belt clip slot at the back of the radio until the clip clicks in place.



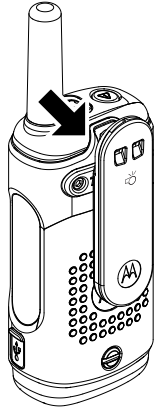
- 2 Attach the belt clip to your pocket or belt strap.

2.3

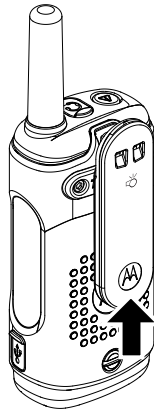
Removing the Belt Clips

Procedure:

- 1 To release the latch, pull the release tab on top of the belt clip.



- 2 Push the belt clip with your other hand towards the top of the radio.



2.4

Turning the Radio On and Off

Procedure:

Hold the **Mode Switch/Power** button until the display turns on or off.

2.5

Channel and Sub Codes

- You must set your radios with the same channel and sub code setting to enable communication with other radios.
- The channel setting controls the radio frequency. To avoid jamming, you can select a channel that is not used by others in your area. For more information on selecting unused channel, see [Scan on page 21](#).
- Match the sub code setting on the transmitting and receiving radios. Otherwise, the receiving radio blocks the received signals. This feature helps you to mute unwanted voices from other radio users transmitting on your channel.
- When sub code is set to zero, radio does not block any signals. Everything that is picked up on the channel is sent to the speaker. Motorola Solutions recommends setting your sub code to zero if you are using T600 series radios with radios that do not support the sub code feature. - You can copy channel and sub code settings from one radio to multiple radios simultaneously with the Easy Pairing feature. For ways to copy channel and sub code settings, see [Radio Overview on page 9](#).

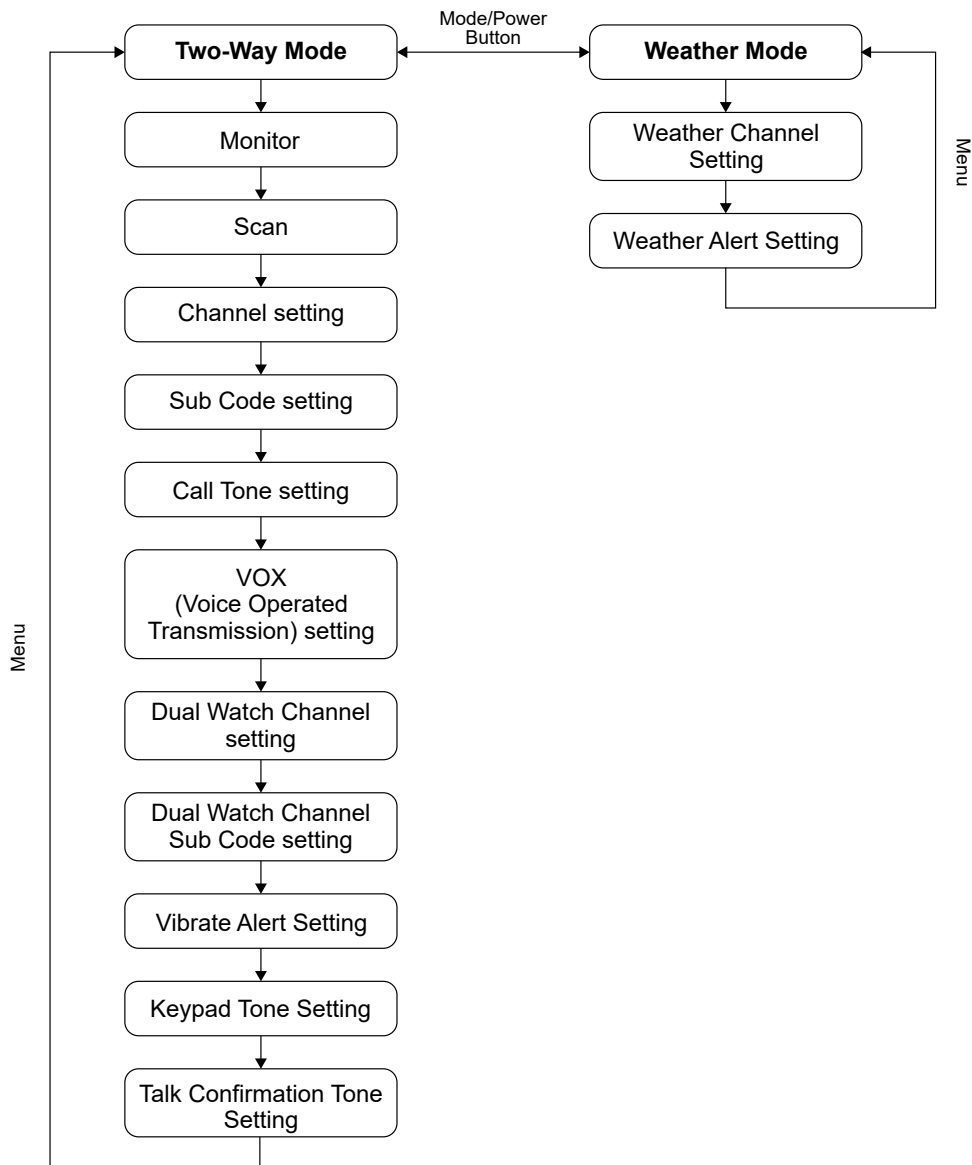
Chapter 3

Navigating the Menu Pages

This chapter shows the ways you can navigate through the buttons in various modes and the instructions.

Procedure:

- 1 Use the **Menu** button to scroll through the menu screen.
- 2 Press the **PTT** to exit any screen and return to home screen.















3.1

Operations in the Menu Screen

This section shows you the operations available in the menu screen and its instructions.

Table 3: Menu Navigation Instruction

Menu Screen	Use the + or - button to do the following:
Two-Way Mode 	<ul style="list-style-type: none"> Two-Way mode is the Home screen that you receive and transmit two-way radio calls. Change the volume setting by pressing the + or - button.
Monitor 	Start or stop monitoring the airwave. You can hear signals transmitted on the channel setting of your radio. If there is no signal, you can hear static.
Scan 	Start or stop scanning the airwave. Radio scans all the channels one after another. When a signal is detected, you hear the signal on the speaker, and the radio displays the channel of the detected signal.
Channel Setting (Channel number blinks)	Change the radio channel settings.
Sub Code Setting (Sub code number blinks)	Change the radio sub code settings.
Call Tone Setting 	Change the call tone sound. There are 20 different sounds available.
VOX or IVOX Setting 	To change the Voice Operated Transmission (VOX) setting, select OFF or L1 to L3 . L3 is the most sensitive. Use L3 in quiet environments.
Vibrate Alert Setting 	Turn the Vibrate Alert on or off. When you turn on the Vibrate Alert, the radio vibrates when call is received. Vibration is paused for 30 seconds after each vibration.
Dual Watch Channel Setting  (Channel number blinks)	In Dual Scan mode, the radio toggles between the main Channel/Sub Code setting and the Dual Scan Channel/Sub Code setting.
Dual Watch Sub Code Setting  (Sub code number blinks)	<ul style="list-style-type: none"> After you adjust the Dual Scan settings in Menu, do not push any button. Allow the radio to time out to Dual Scan mode. From Dual Scan mode, press the Menu button to exit to Home screen. From Dual Scan mode, the PTT button does not exit to Home screen.
Keypad Tone Setting 	Turn on or off the click sound when a key or a button is pressed.
Talk Confirmation Tone Setting 	Turn the Talk Confirmation Tone on or off.

Menu Screen	Use the + or - button to do the following:
	This tone is transmitted when you release the PTT button, similar to saying "Roger" or "Over." This tone indicates to others that you have finished talking.
Weather Mode 	<ul style="list-style-type: none">• In this mode, you can listen to weather broadcast from NOAA or Environment Canada.• Adjust the volume setting by pressing the + or - button.• The radio switches to Two-Way mode if no button is pressed for five minutes.
Weather Channel Setting (Weather Channel Setting blinks)	Change the weather channel setting by pressing the + or - button.
Weather Alert Setting 	Turn on or off the weather alert feature by pressing the + or - button.

Chapter 4

Radio Usage

This section shows the ways you can use your radio.

4.1

Talking or Transmitting

Ensure that you are in the Two-Way mode by looking for the Two-Way icon on the LCD. You can return to the Two-Way mode by pushing the PTT button briefly.

Procedure:

- 1 Press and hold the **PTT** button, then start talking into the microphone.
- 2 Release the **PTT** button to stop transmission.



NOTE: Do not press the PTT button when others are talking. When more than one radio transmits on the same channel, the airwave is jammed, and all transmissions are lost.

4.2

Listening or Receiving

Procedure:

- 1 The radio speaker receives signal automatically if the radio is set to the same channel and code as the transmitting radio.
- 2 Ensure that the speaker volume is set to an appropriate level.

4.3

Adjusting Speaker Volume

Procedure:

1. Press the **+** or **-** button from the home screen.

4.4

Headset Usage

- When a headset is connected to the radio, the radio speaker is disabled. Wear the connected headset to monitor and receive messages.
- If your headset has the PTT button, you can use the button to make a transmission with the microphone on the headset.
- You can still use the PTT button on the radio to make a transmission with the microphone on the radio.

4.5

Listening to Weather Broadcast

Procedure:

- 1 Go to the **Weather Radio** page to listen to the weather broadcast.



NOTE: Your radio does not receive signal from other two-way radios when in the **Weather Radio** page.

- 2 From the **Weather Radio** page, press the **Menu/Lock** button.
- 3 Change the **Weather Channel Setting** and **Weather Alert Setting**.

4.6

Weather Alert

Your radio can be set to respond to NOAA Weather Radio emergency messages. A special alarm tone sounds an alert and turns on the weather receiver to give you immediate weather and emergency information.

You can turn this alert on or off in the **Adjust Weather Alert Menu** page.

Chapter 5

Advanced Features

This chapter explains the advanced features of your radio. For ways to operate the features mentioned in this chapter, refer to [Operations in the Menu Screen on page 17](#).

5.1

iVOX or VOX

The microphone detects if you are talking when using Internal Voice Operated Transmission (iVOX) or Voice Operated Transmission (VOX). If you are talking, the radio triggers the transmission automatically.

- When iVOX is displayed, the radio uses the built-in microphone to detect your voice.
- When a VOX headset is connected to the radio, VOX is displayed and the headset microphone is used to detect your voice.

To select the VOX/iVOX sensitivity level, select the following settings:

Table 4: VOX/iVOX Sensitivity Level

Level	Descriptions
OFF	Turn off the VOX or iVOX settings.
L3	High Sensitivity for quiet environments. Speaking softly is enough to trigger the VOX or iVOX transmission.
L2	Medium Sensitivity for most environments.
L1	Low Sensitivity for noisy environments. Speak up to trigger the VOX or iVOX transmission.



NOTE: Pressing the **PTT** button cancels the VOX or iVOX transmission.

5.2

Scan

Radio scans for voice activity by cycling through the channels. When signals are detected, the signal is sent to the speaker. Scan feature allows you to find out the channel that is used by other groups and has heavy traffic. Scan feature helps you to avoid busy channels when deciding the channel to use for your group.

5.3

Monitor

You can hear everything including noise on your current radio channel. This feature allows you to monitor a channel for weak signals.

5.4

IP-67 Waterproof Rating

This radio is waterproof to IP-67 standards. The radio can withstand submersion up to 1 meter of water for up to 30 minutes, but only when the battery cover and headset accessory port are sealed.

Open the battery compartment door or headset port cover only when the radio is dry. Installation of batteries and accessories must be in dry environments only. Ensure that the battery compartment and accessory port seals are free of all dirt and debris.

To maintain audio quality, if the radio is submerged in water, shake the radio briskly to remove water trapped inside the speaker grille and microphone port. Motorola Solutions recommends rinsing the radio with fresh water if the radio is exposed to salt water to preserve the life of the radio.

5.5

Water Sensor

When the radio comes in contact with water, the white LED begins to flash until the battery is dead. Press the **Flashlight** button to turn off the flashing LED.

5.6

Emergency Alert Mode

You can use the Emergency Alert feature to signal members in your group if you require urgent help. After pressing the Emergency button, a warbling alert tone is emitted from your radio and transmitted to the radios in your group. The T600 series radios in your group automatically advance the speaker volume to the maximum setting and sound a warbling alert tone for 8 seconds. After 8 seconds, the alert tone stops. Then, the radio is in hands free mode for 22 seconds, allowing you to talk without pressing the **PTT** button. For the 30 seconds duration of the Emergency Alert mode, T600 series radio controls and buttons are locked to maximize reception of the emergency message.

This chapter explains the features of your radio.

6.1

Battery Information

- The rated battery life is measured under the industrial standard 5-5-90 duty cycle under lab conditions. 5 % of the time transmitting, 5 % receiving with speaker on, and 90 % waiting for incoming call.
- Charge the NiMH batteries once every three months when not in use.
- Do not leave the radio connected to a charger permanently.
- Remove the battery from the radio after using for storage purposes.
- Store the NiMH batteries in a temperature between $-20\text{ }^{\circ}\text{C}$ to $35\text{ }^{\circ}\text{C}$ and in low humidity.

6.2

Push-to-Talk Time-Out Timer

To avoid airwave traffic congestion, transmission ends after one minute even if the **PTT** button is still pressed. You can reset the timer by releasing the **PTT** button briefly.
